- **A82053 Nutwood Medical Centre and A82065 Peninsula Medical Practice** – The CCG Primary Care Commissioning Committee considered an application to merge from A82053 Nutwood Medical Centre and A82065 Peninsula Medical Practice. The application was approved, with the merger being effective from 2 October 2020. The merged practice continued under A82053 with A82065's code ceasing.

#### Boundary Changes
